

STONY CREEK METROPARK

Stony Creek Park is North of Utica & East of Rochester, Michigan.

To get to the park: Take M-59 to M-53 and go north to 26 Mile Road. Go west on 26 Mile Rd past Mound Road and follow the signs to the left into the park. **OR ALTERNATELY**, You can take M-59 to Dequindre Rd and go north to 25 Mile Rd (Runyan Rd). Turn right (east) on 25 Mile and go about 1 mile to Shelby Rd. Turn Left (north) and follow the signs into the park.

Park Info: A great trail system for mountain biking has been established at Stony Creek. It includes some less technical, and some very challenging sections. If you have not experienced these trails yet, come on out... You'll be glad you did! The riding and running here are great, and there is a lake for boating with a beach for swimming. The park is open year 'round.

Park entry is \$4 per car on race day, or an annual permit is \$20.

COURSE INFORMATION

The **Time Trial Start / Finish** is at **Baypoint Beach** and the course is a 13-mile loop primarily on the traditional mountain biking trails that include challenging hills, technical single track, fast flats, and... for this race, *a stream crossing!* **YOU CAN TAKE A COOLING SWIM AFTER THE RACE SINCE WE START AND FINISH AT BAYPOINT BEACH!**

The **"12th Annual" Michigan Mountain Bike Time Trial Race Series** consists of 5 races. (Contact Tailwind for a copy of the TT Series Categories, Point System, and Rules.) Everyone who rides a race in the TT Series will have their points tabulated. You must ride in 3 or more TT Series races to be eligible for an **Overall TT Series Award**, and we total the points of your 4 highest point finishes for overall standings.

NOTE: The Pontiac Lake TT is held under USAC rules as it is also Race #1 in the Tailwind USAC MTB State Championship XC Series. For that one Time Trial only, *Elite & Expert racers require an Annual USAC Mtn License.*

Sport Racers	10:40-11:29
Beginner Racers	11:30-12:14
Tand./Single Spd.	12:15-12:30

Pre-Registered racers start first, then Day-Of racers start in the order they register in (still within their Category Start Time Block).

All Racers (Pre-Registered & Day-Of) Start Within Their Category Start Time Blocks

Note: Start Time Blocks may be different at other Time Trial locations (see race flyers).

Riders start Two At A Time at 30 second intervals.
