Directions to TAILWIND 2003 Cyclo-Cross Race Sites...

SERIES RACE #1: Stony Creek Metropark is in Shelby Township, MI. (east of Rochester). Take M-59 to M-53 and go north to 26 Mile Road. Go west on 26 Mile Rd past Mound Road and follow the signs to the left into the park. **OR ALTERNATELY**, You can take M-59 to Dequindre Rd and go north to 25 Mile Rd (Runyan Rd). Turn right (east) on 25 Mile and go about 1 mile to Shelby Rd. Turn Left (north) and follow the signs into the park. **Park entry is \$4 per car** on race day, or an annual permit is \$20.

SERIES RACE #2, #5, and Michael R. Rabe UCI Race: Bloomer Park is in Rochester Hills, MI., at the North end of John R Road. Take M-59 to Rochester Rd and go north to Avon Rd. At Avon Rd. turn right (east) and go 1 mile to John R and turn left (north). John R goes directly into Bloomer Park. **Park entry is \$3 per car** on race day.

SERIES RACE #3: Munson Park From I-75, take the Elm Street Exit (Exit # 14). Go west on Elm (Elm Street turns into N. Custer) and the park will be about 2 miles from the expressway on the Right.

From US-23, get off at Exit #17 (Dundee Exit). Go Left (east) on M-50 ~8-miles to the 1st Stoplight at Raisinville Road. Go Left (north) on Raisinville Rd ~100 yards and turn Right onto N. Custer. The park is ~1/2 mile farther on your Left.

SERIES RACE #4 - Riverside Park is in Grand Rapids, MI. From I-96 take I-196 toward downtown Grand Rapids. Go to the US-131 exit and take 131 north to the Ann Street Exit. Turn Left at the traffic light to go back over the river, then turn Left onto Monroe. Riverside Park is on the left, take 2nd park entrance to the Island Shelter.

SERIES RACE #5: Bloomer Park is in Rochester Hills, MI., at the North end of John R Road. Take M-59 to Rochester Rd and go north to Avon Rd. At Avon Rd. turn right (east) and go 1 mile to John R and turn left (north). John R goes directly into Bloomer Park. **Park entry is \$3 per car** on race day.

SERIES RACE #6: Hudson Mills Metropark is in Dexter, MI, on North Territorial Road at the crossing of the Huron River, twelve miles northwest of Ann Arbor. Take US-23 to the North Territorial Road Exit (#49) and go west approx. 8 miles to the park entrance. **Park entry is \$4 per car** on race day, or an annual permit is \$20.

SERIES RACE #7: Lower Huron Metropark in Belleville, MI. Take I-94 to the Haggerty Road Exit (#192) and take Haggerty Road south to Huron River Drive. Go across Huron River Drive and you immediately enter the park. **Park entry is \$4 per car** on race day, or an annual permit is \$20. **MICHIGAN USCF STATE CHAMPIONSHIP EVENT.**

The basic time schedule on race day is as follows:

Racer registration opens at 10:00a, Closes 15 minutes before each race

'C' Race starts at 11:00a (30 minute race): C-MEN, C-WOMEN, JUNIOR 14-UN

'B' Race starts at 12:00 noon (45 minute race): ELITE WOMEN, B-MEN and JR 15-18, MASTERS 35+ and 45+

'A' Race starts at 1:15p (1 hour race) ELITE MEN

Awards presentation approx. 2:45p

NOTE: Either An Annual USA Cycling License (USCF or NORBA) or a One Day License (purchased at registration) is required for participation in A or B events. C-event does not require licensing.
